Global Connection Inc. of Florida ("Global") is a certificated Alternative Local Exchange Carrier (Docket No. 010152-TX, Certificate No.7830) providing telecommunications services to approximately 406 customers in Florida. The Company is certified in a total of 31 states. The primary business in which Global is engaged is the resell of residential prepaid telecommunications services.

This filing is simply a change in the name of the entity and is not the result of a change in control or merger/acquisition activity. 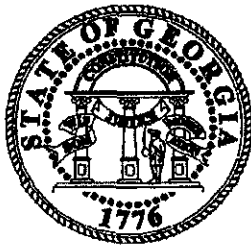

SECOND: The dissolution of the Corporation was authorized on the 6th day of June, 2008.






