## SUMTER ELECTRIC COOPERATIVE, INC.'S REPORT ON STATUS OF TERRITORIAL AGREEMENT BETWEEN CLAY ELECTRIC COOPERATIVE, INC. AND SUMTER ELECTRIC COOPERATIVE, INC.

In Order No. PSC-95-0783-FOF-EC issued on June 29, 1995 in Docket No. 950333-EC the Commission approved the territorial agreement entered into by and between Clay Electric Cooperative, Inc. and Sumter Electric Cooperative, Inc. Section 5.2 of said Agreement calls for an annual report from Sumter Electric Cooperative, Inc. providing the status of the Agreement and any modifications proposed in the Agreement.
