COOPERATIVE, INC.


In Order No. PSC-96-0900-FOF-EC, issued on July 15, 1996 in Docket No. 960468-EC the Commission approved the territorial agreement entered into by and between Central Florida Electric Cooperative, Inc. and Sumter Electric Cooperative, Inc. Section 5.2 of said Agreement calls for an annual report from Sumter Electric Cooperative, Inc. providing the status of the Agreement and any modifications proposed in the Agreement.

This is to advise the Commission that the subject territorial agreement remains in full force and effect and that no modifications have been proposed in such agreement nor have the parties encountered any disputes concerning the provisions of such agreement.
