I am writing this letter to give you an update concerning the installation of the proforma plant additions. I will attempt to explain each in the same numerical format as your email.

- (12.) We have applied for a permit with the FDEP to go from gas chlorine at the water plant to liquid chlorine. We are still waiting on the status of this permit.
- (13.) This item still needs to be completed. We are waiting to switch the water plant to liquid chlorine and then we will complete this work at the wastewater plant site.
- (22.) This item still needs to be completed. We are still working with Polk County to see if the EMS station will be connected. We have a meeting scheduled for June 16, 2008. The meeting was postponed until July 25, 2008. As a result of the meeting we are talking with the county consultants about extending lines.
- (26.) This item still needs to be completed. We are currently working on this item and expect to have it completed by end of summer
