1 Q. PLEASE STATE YOUR NAME AND BUSINESS ADDRESS.

2 A. My name is Bruce Narzissenfeld and my business address is 702 North
3 Franklin Street, Tampa, Florida 33602.

4 Q. BY WHOM ARE YOU EMPLOYED AND IN WHAT CAPACITY?

5 A. I am employed by Peoples Gas System ("Peoples" or the "Company") as
6 Vice President - Operations, having held that position since July 2006.

7 Q. PLEASE PROVIDE A BRIEF OUTLINE OF YOUR
8 EDUCATIONAL BACKGROUND AND BUSINESS EXPERIENCE.

9 A. I graduated from the University of Florida in 1979 with a Bachelor of
10 Science degree in accounting. Upon graduation, I was employed by
11 Arthur Andersen, where I worked for four years in the auditing group. On
12 leaving Arthur Andersen, I joined Florida Power & Light Company where
13 I worked in Finance from 1984 to 1985. I have been with the TECO
14 Energy family of companies since 1985, and have been employed by
15 Peoples since 1998. I served as Peoples' Assistant Controller until
16 becoming Vice President - Operations. I have been a Certified Public
17 Accountant since 1980, and earned a Masters in Business Administration
18 from the University of Tampa in 1988.

19 Q. WHAT ARE YOUR CURRENT RESPONSIBILITIES?

20 A. As Vice President - Operations, I am responsible for all operations,
21 maintenance and construction activities throughout the state and work
22 closely with our sales organization to ensure seamless coordination of
23 customer additions and expansion projects. Additionally, I am responsible
24 for development, communication and implementation of business
25 strategies.
