This letter is in reference to the voluntary forfeiture of the CLEC certificate No. 8716 and IXC Registration TJ982 in lieu of the payment of \$2,500 penalty imposed on Effectel, Corp for the failure to review in a proper manner the resumes submitted to the Florida Public Service Commission.

Effectel, Corp did not have any customers during the year 2008, did not hold any customers deposits and did not make any sales to customers. Effectel, Corp is paying the Regulatory fees for the year ended December 31, 2008 in the amount of \$1,300 (CLEC \$600.00 and IXC \$700.00) check number 1224

The decision to forfeit the certificates is due to personal illness in the family, general economic difficulties and difficulties in starting the business again. Effectel, Corp will be closed as of December 31, 2008 with the Florida Department of State and it will not be renewed.
