



**JEA'S MOTION FOR LEAVE TO FILE
SUPPLEMENTAL TESTIMONY**

JEA, by and through its undersigned counsel, hereby moves for leave to file supplemental testimony for the purpose of updating its Need for Power Application and supporting testimony.

In support, the Applicants state:

1. On September 30, 2008, JEA initiated this proceeding by filing a Need for Power Application, Exhibit No. ___ [GEC-1] and supporting testimony.

2. In response to recent developments in the municipal credit markets, JEA has deferred for one year a large portion of capital expenditures initially planned for Fiscal Year 2009. Delaying the 2009 capital expenditures will likely delay the Greenland Energy Center (GEC) combined cycle conversion commercial operation date by one year. In addition, as a result of the recent credit market developments, JEA has adjusted its forecasted long-term municipal bond interest rate.

3. JEA has met with Commission Staff to discuss these recent developments and the need to file supplemental testimony to address their potential impact on the proposed GEC project and the economic analyses presented in JEA's Need for Power Application and supporting testimony. As a result of those discussions, the scheduled hearing date has been moved to February 12, 2009, in order to provide Staff sufficient time to conduct additional discovery regarding the matters addressed in JEA's supplemental testimony.


