Pursuant to Rule 25-9.044(1), Florida Administrative Code, please accept this letter as notification that on October 28, 2009, Chesapeake Utilities Corporation (Chesapeake), a Delaware corporation, and Florida Public Utilities Company consummated a corporate transaction, whereby Florida Public Utilities Company became a wholly-owned subsidiary of Chesapeake Utilities Corporation.

Chesapeake's existing Florida Division (GU616), which provides service under the fictitious name "Central Florida Gas Company," will continue to operate its natural gas distribution utility using the rates, rules, and classifications on file with the Commission. The newly acquired subsidiary, Florida Public Utilities Company, will continue to operate under the name "Florida Public Utilities Company," as well as the rates, rules, and classifications currently on file with the Commission for both the natural gas utility business (GU603) and the electric utility business (EI803).

To the extent required by Rule 25-9.044, Florida Administrative Code, Chesapeake will


