Dear Ms. Cole:

1. This correspondence is to request the cancellation, by the Florida Public Service Commission ("FPSC" or "Commission"), of the above referenced Competitive Local Exchange Telephone Utility ("CLEC") certification held by the Florida Public Telecommunications Association, Inc. ("FPTA"), with such cancellation to be made effective as of 12/31/09.

2. Cancellation of this certificate is being requested based upon the fact that FPTA has never done any CLEC business in the State of Florida (or in any other jurisdiction), has made no sales of such services, has no customers, has no plans to provide any CLEC services, and thus has no reason at this point in time to continue maintaining this FPSC certification in an active status.

3. Because FPTA has no customers and holds no customer deposits, there is no need for FPTA to issue any notifications regarding cancellation of its CLEC authority. FPTA is current on its Regulatory Assessment Fee ("RAF") obligations for all years prior to the current year, and will pay the current year's RAF minimum assessment (\$600.00) prior to the January 30, 2010 due date.
