**INTERCONNECTION AGREEMENT**

This Agreement is made effective on the 1st day of November, 2009, and is between TDS Telecommunications Corporation, as agent for the Florida operating companies listed in Appendix A (“TDS TELECOM”) and MCC Telephony of Florida, LLC, a Delaware limited liability corporation, with its principal place of business at 100 Crystal Run Rd, Middletown, NY 10941 (“Mediacom”).

WHEREAS, the Telecommunications Act of 1996 (the “Act”) was signed into law on February 8, 1996; and

WHEREAS, section 252(i) of the Act requires TDS TELECOM to make available any interconnection, service, or network element provided under an agreement approved by the appropriate state regulatory body to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety; and

WHEREAS, Mediacom has requested that TDS TELECOM make available the interconnection agreement in its entirety executed between TDS TELECOM and Sprint Communications Company, L.P. (“SPRINT”) dated October 1, 2005.

NOW, THEREFORE, in consideration of the promises and mutual covenants of this Agreement Mediacom and TDS TELECOM hereby agree as follows:

1. Mediacom and TDS TELECOM shall adopt in its entirety the SPRINT Interconnection Agreement dated October 1, 2005 and any and all amendments to said Agreement executed and approved by the appropriate state regulatory commission as of the date of the execution of this Agreement. The SPRINT Interconnection Agreement and all amendments are attached hereto as Exhibit 1 and incorporated herein by this reference.
2. The term of this Agreement shall be from the effective date as set forth above and shall expire as set forth in Section 5 of the SPRINT Interconnection Agreement.
3. For purposes of applying the terms of this Agreement and the Parties respective access tariffs, all traffic exchanged between Mediacom and TDS TELECOM shall be considered telecommunications traffic, regardless of the technology used to originate, transport or terminate the calls.
