## AMENDMENT TO THE AGREEMENT BETWEEN ORLANDO TELEPHONE COMPANY, INC. AND BELLSOUTH TELECOMMUNICATIONS, INC. d/b/a AT&T FLORIDA

This Amendment (the "Amendment") amends the Interconnection Agreement by and between BellSouth Telecommunications, Inc.<sup>1</sup> d/b/a AT&T Florida ("AT&T Florida") and Orlando Telephone Company, Inc. ("CLEC"). AT&T Florida and CLEC are hereinafter referred to collectively as the "Parties" and individually as a "Party".

WHEREAS, AT&T Florida and CLEC are Parties to an Interconnection Agreement under Sections 251 and 252 of the Communications Act of 1934, as amended (the "Act"), dated April 21, 2006 and as subsequently amended (the "Agreement"); and

**NOW**, **THEREFORE**, in consideration of the promises and mutual agreements set forth herein, the Parties agree to amend the Agreement as follows:

- 1. Attachment 2 is amended by adding the following section:
  - 4.8.8 Rates for branding features are set forth in Attachment 3, Exhibit A.
- 2. The Directory Assistance and Operator Assistance Rates are added as attached hereto and incorporated herein by this reference
- 3. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
- 4. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
- 5. This Amendment shall not modify or extend the Effective Date or Term of the underlying Agreement, but rather, shall be coterminous with such Agreement.
- 6. This Amendment shall be filed with and is subject to approval by the State Commission and shall become effective ten (10) days following approval by such Commission.
