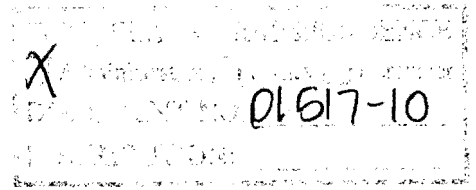

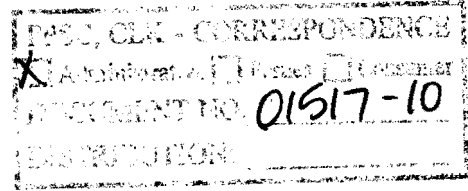

### Case Background

The Commission conducts an annual fuel and purchased power cost recovery clause (fuel clause) hearing<sup>1</sup> as part of its authority to set fair and reasonable electric utility rates pursuant to Section 366.05, Florida Statutes (F.S.). 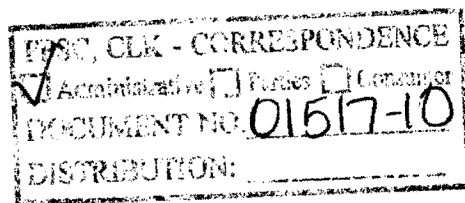
