While catching up on outstanding confidentiality requests, staff has identified several requests for confidential treatment for Progress Energy Florida, Inc.'s (PEF) 423 Fuel Reports for the months of September, 2007, through February, 2008, filed during the 2007 and 2008 fuel clause proceedings which have not yet been acted upon.
