**Re: Docket No. 080562-WU - Request for approval of amendment to connection/transfer sheet, increase in returned check charge, amendment to miscellaneous service charges, increase in meter installation charges, and imposition of new tap-in fee, in Marion County, by East Marion Sanitary Systems, Inc.**

Dear Sir or Madam::

East Marion Sanitary Sewer System (East Marion) applied for and was approved for new rates. Part of the order approving the rates, required East Marion to provide irrigation meters at the old rates to certain customers who had previously requested those irrigation meters prior to the date of the Agenda Conference approving the new rate.
