JOINT MOTION FOR EXTENSION OF TIME

Verizon Florida LLC and Bright House Networks Information Services (Florida), LLC (collectively, the "Parties") file this joint motion requesting that the filing date for direct testimony and exhibits be extended from March 12, 2010 to March 26, 2010 and that the filing date for rebuttal testimony and exhibits be extended from April 16, 2010 to April 23, 2010. In support of this joint motion, the Parties show the following:

1. The Parties have agreed in principle to settle certain key issues in this case and are in the process of memorializing that agreement. The Parties also plan to negotiate concerning the resolution of additional issues over the next two weeks and it is their hope that as a result the scope of this case will be reduced even further.

2. The Parties are requesting relatively short extensions of time for the filing of direct and rebuttal testimony and exhibits so they can focus on memorializing their agreement and resolving additional issues. Allowing additional time so the parties can complete these discussions will promote administrative efficiency by reducing the number of issues on which testimony and other evidence may be necessary.

3. The requested extension will not affect any of the other dates set out in the Order Establishing Procedure in this docket.
