

Tampa Electric Company ("Tampa Electric" or "the company") files this its unopposed motion for an extension of time in the above proceeding and, says:

1. Tampa Electric is in need of a brief extension of time within which to submit its direct testimony and exhibits in this proceeding. The company's testimony and exhibits are currently due April 9, 2010. Tampa Electric seeks an extension of time through and including Monday, April 26, 2010, within which to file its direct testimony and exhibits.

2. At the issue identification meeting conducted March 15, 2010 Intervenor, Energy 5.0, committed to file its direct testimony and exhibits on the same date as Tampa Electric, or Monday, April 26, 2010, if this motion is granted.

3. At the issue identification meeting the parties also discussed and agreed that it would be appropriate to move the due date for Intervenor direct testimony and exhibits (other than those of Energy 5.0) from May 3, 2010 to May 10, 2010. Tampa Electric also understands that Staff would seek an extension of time to file any Staff direct testimony and exhibits from May 10 to May 17, 2010.

4. All other dates on the Case Assignment and Scheduling Record would remain the same. The relief requested herein would not appear to have any adverse effect on the conduct of the proceeding. Tampa Electric conferred with all parties represented at the March 15, 2010




