Non-party CoPOWR responds to Applicant Skyland Utilities, LLC's First Request for Production of Documents to CoPOWR ("Request to Produce") as follows:

- 1. Non-party CoPOWR objects to responding to the Request to Produce. Florida Rule of Civil Procedure 1.350 only allows a request to produce pursuant to that rule to be served by a party on a party. Rule 1.350 states in pertinent part (emphasis supplied):

- 2. The Florida courts have acknowledged that a request to produce pursuant to Rule 1.350 may only be served on a party. See e.g. Sjuts v. State, 754 So.2d 781, 782 (Fla. 4th DCA 2000)(finding that the rules of civil procedure provide for certain discovery tools that may be used only by one party on another party, and including requests for production pursuant to Rule 1.350 in that group).
