**NOTICE OF WITHDRAWAL OF REQUEST FOR VARIANCE  
FROM RULES 25-4.066 AND 25-4.070, F.A.C.**

Verizon Florida LLC ("Verizon") hereby withdraws its request for a variance from Rules 25-4.066 and 25-4.070, Florida Administrative Code. In its Amended Petition, Verizon sought the variance because the systems changes it had made to comply with recent amendments to those rules had not enabled it to provide the required reports for basic customers only. Since filing its Amended Petition, Verizon has developed a manual process that will enable it to provide such reports in compliance with Rules 25-4.066 and 25-4.070. Verizon therefore no longer needs the variance it had requested with respect to those rules.

For the reasons stated in its original Petition and Amended Petition, Verizon continues to request a variance from Rules 25-4.0185 and 25-4.073 with respect to call-answer-time reporting.
