

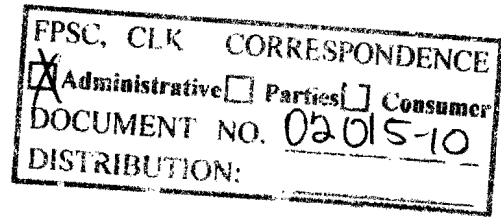

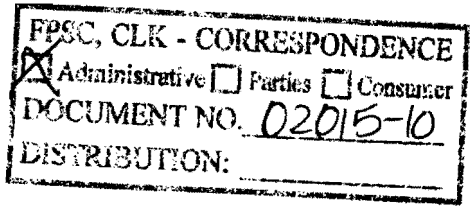

Lighthouse Utilities Company, Inc. (Lighthouse or Utility) is a Class B utility serving approximately 1,361 water customers in Gulf County. Rates were last established for this Utility in 1988.¹ On September 1, 2010, Lighthouse filed an application with the Florida Public Service Commission (PSC) for an increase in its rates and charges for water service.
