TAMPA ELECTRIC COMPANY'S REPORT ON STATUS OF TERRITORIAL AGREEMENT BETWEEN TAMPA ELECTRIC <u>COMPANY AND WITHLACOOCHEE RIVER ELECTRIC COOPERATIVE, INC.</u>

Pursuant to Article IV, Section 4.1 of the Territorial Agreement between Withlacoochee River Electric Cooperative ("WREC") and Tampa Electric Company ("Tampa Electric"), as approved in Order No. 23905 issued in Docket No. 900752-EU on December 26, 1990, this filing will serve as Tampa Electric's report on the status of such agreement.

This is to advise the Commission that the subject territorial agreement remains in full force and effect.

This will also update the Commission on the status of matters in Docket No. 041408-EI, <u>In</u> <u>Re: Joint Petition of Tampa Electric Company and Withlacoochee River Electric Cooperative, Inc.</u> <u>for expedited interim approval of customer transfers pending consideration of joint application for</u> <u>permanent relocation of territorial boundaries</u>. On February 16, 2006, the Commission entered its proposed agency action order¹ approving an amendment to the territorial agreement between Tampa Electric and WREC. The amendment modifies the retail territorial boundaries of Tampa Electric and WREC in Pasco County. The Commission found the proposed amendment to be in the public interest. The proposed agency action approved by the Commission became final with the issuance of Order No. PSC-06-0200-CO-EU, dated March 13, 2006.

On March 17, 2008 Tampa Electric and WREC filed a joint petition for approval of limited amendments to their current territorial boundaries within the Meadow Point subdivision is Pasco County, Florida. That joint petition was approved as a matter of proposed agency action on June 23, 2008 (Order No. PSC-08-0416-PAA-EU, in Docket No. 080141-EU; Consummating Order No. PSC-08-0449-CO-EU issued July 15, 2008).
