Enclosed is Verizon Florida's response to staff's March 10 request for a listing of Lifeline customers as of February 28, 2010. This filing is being made on the CD provided by staff.

Verizon made several attempts to convert the file to Microsoft Office Access format as Staff requested, but was unable to do so. We therefore have provided the data in Excel format.

Please note in addition that Verizon currently is unable to provide birthdates and Social Security numbers. Those fields are encrypted as part of CPNI privacy standards within Verizon's internal systems. Building an interface to obtain this information would require a substantial amount of time and resources.

Lifeline personal identifying information is confidential pursuant to Chapter 364.107, Florida Statutes. Therefore, this filing is made under a Claim of Confidentiality pursuant to F.S. 364.183(1) and Rule 25-22.006(5), Florida Administrative Code. Verizon understands the information must be kept confidential until returned to Verizon.
