

**ASSIGNEE'S AMENDED MOTION TO APPROVE FINAL REPORT AND FEES
TO ASSIGNEE, ASSIGNEE'S COUNSEL, ASSIGNOR'S COUNSEL, SPECIAL
EXAMINER AND SPECIAL EXAMINER'S ACCOUNTANT,
DISBURSE REMAINING FUNDS TO PRIORITY AND UNSECURED CREDITORS,
DISCHARGE ASSIGNEE AND CLOSE CASE**

COMES NOW the Assignee, Michael Phelan, by and through his undersigned attorney and pursuant to §727.111(5) and §727.116, Florida Statutes, hereby moves this court for an Order closing the case, approving the Assignee's Amended Final Report of Receipts and Disbursements, Fees and Expenses to Assignee, Assignee's Counsel, Assignor's Counsel, Special Examiner and Special Examiner's Forensic Accountant, disbursement to priority and unsecured creditors and discharging the Assignee, and as grounds therefore would show as follows:

1. On June 2, 2008, a Petition was filed commencing an Assignment for the Benefit of Creditors Proceeding pursuant to Chapter 727, Florida Statutes, made by LATIN NODE, INC., Assignor, to Michael Phelan, Assignee.
2. Notice of the Assignment was duly issued to creditors by the Assignee by mail, and further, Notice of Publication, pursuant to Florida Statutes Chapter 727.111(1) was published in the Miami Daily Business Review.
3. The deposition of the Assignor was duly taken after notice to creditors on July 14, 2008.

4. On April 23, 2009, the Assignee filed his Motion to Approve Final Report and Fees, to Assignee, Assignee's Counsel and Assignor's Counsel, Disburse Remaining Funds to Priority and Unsecured Creditors, Discharge Assignee and Close Case. ("Assignee's Final Motion")

5. An objection to Assignee's Final Motion was filed by Empresa Honuranc de Telecomunicaciones ("Hondutel") on May 4, 2009.

6. By Order dated August 28, Hon. Jorge Perez was appointed Special Examiner to review the issues raised by Hondutel in its objection. The Special Examiner hired the firm of Berkowitz Dick Pollack & Brant as his forensic accountants to assist him in the review process.

7. On February 16, 2010, the Special Examiner filed his Report concluding that there were

"...taking fully into account the serious allegations asserted by Hondutel, it is the undersigned Examiner's conclusion that there were no preferences or fraudulent conveyances including (a) transfers of cash, (b) transfers of business contracts, relationships or other forms of goodwill, or (c) transfers of equipment that occurred in this matter."

(A copy of the Special Examiner's Report is on file with the Court or can be obtained from undersigned counsel.)

8. The Assignee now again moves this Court to close the Assignment Proceeding.

FINAL REPORT

9. Annexed hereto as Exhibit "A" is the Assignee's Amended Final Report showing total receipts of \$266,401.41.

PROPOSED DISTRIBUTION

10. The Assignee has reviewed the claims on file and the schedules of the Assignor. Annexed hereto as Exhibit "B" is the proposed amended priority and unsecured creditors distribution schedule. The Assignee will pay all remaining funds after fees and expenses, as indicated on Schedule "B".

FEES AND EXPENSES

11. The Special Examiner's Fees and costs are \$20,861.88 and the fees and costs of his forensic accountant are \$9,426.00.

12. The Assignee fees are \$26,613.52 and the Assignee's counsel's fees and costs are \$74,600.00. (Counsel's Statement and Supplemental Statement for Services Rendered are on file with the Court).

13. The Assignor's counsel's fees and costs are \$38,322.50. (Counsel's Statement for Services Rendered can be obtained from Assignor's counsel).

14. The Assignee now seeks authorization of the Court to allow him, pursuant to Florida Statute 727.108(10), to make distribution to priority and unsecured creditors as indicated on Exhibit "B", and pay the fees and expenses as set forth on Exhibit "A".

15. There are no further assets to liquidate for the benefit of this Estate. The Court will be requested to retain jurisdiction to hear and determine any awards for attorneys fees from parties who filed 57.105 motions. Any awards granted to counsel for the Assignor will be reimbursed to the Estate for future distribution to unsecured creditors.

16. Pursuant to §727.111(4), Florida Statutes, any objections must be filed with the Court and served upon the Assignee and the Assignee's attorney no later than April 23, 2010. Objections, if any, shall be served upon the Assignee, Michael Phelan, c/o Moecker & Associates, 6861 SW 196th Avenue, Bldg. 200, Fort Lauderdale, FL 33332, Assignee's counsel, Jay M. Gamberg, Esq., Gamberg & Abrams, 4000 Hollywood Blvd., Suite 350N, Hollywood, FL 33021 and Assignor's counsel, Lawrence M. Schantz, Esq., Adorno & Yoss, LLP, 2525 Ponce de Leon Blvd., Suite 400, Miami, FL 33134. If no objections are timely filed and served, the Assignee will disburse the funds as indicated on Exhibit "A" without further order of the Court. If objections are filed, they will be heard on April 27, 2010 at 9:30 a.m. before the Hon. Barbara Areces, in her Chambers in Room 414 at the Miami-Dade County Courthouse, 73 West Flagler Street, Miami, FL 33130.

WHEREFORE the Assignee respectfully prays that an Order be entered, after final hearing, upon notice to all creditors pursuant to Florida Statutes 727.111(5) as follows:


- a) That the case be closed with the Court retaining limited jurisdiction to hear 57.105 motions, if any.;
- b) That the Assignee be authorized to make payment to priority and unsecured creditors as indicated on Exhibit "B", attached hereto;
- c) That the Assignee's Petition for Discharge and Final Report of Receipts and Disbursements be approved;
- d) That the fees and costs to the Assignee, his attorney, the Special Examiner, Special Examiner's forensic account and Assignor's attorney be approved;
- e) That the Assignee be discharged and his bond released, and for such other further and different relief as to the Court deems just and proper.
