



The North $\frac{3}{4}$ of the East $\frac{1}{2}$, the East $\frac{1}{2}$ of the North $\frac{1}{2}$ of the West $\frac{1}{2}$, and the West $\frac{1}{2}$ of the North $\frac{1}{2}$ of the West $\frac{1}{2}$ lying North of West Farm Road. (West Farm Road can be described approximately as follows: From the Northeast corner of said section Run 3,309 feet South along the East line to the intersection of West Farm Road; thence North 86 degrees West along said road a distance of 1,095 feet; thence North 59 degrees West a distance of 3,017 feet; thence North 77 degrees West a distance of 1,338 feet to the intersection of said road with the West line of said section.
