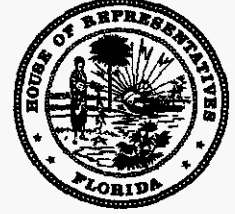

28 was Beata Jordan, representative of East Marion Sanitary Systems, Inc. Ms. Jordan's
29 response was that they were not putting irrigation meters in at this time. She would send
30 my request to Herb Hein for approval. He did not respond. In December, 2009, Ms.
31 Jordan told me to fill out an application and give her \$70.00 for the meter. By that time I
32 was so discouraged I did not respond. Approximately the middle of February, 2010, Ms.

1 Jordan gave me an application finally! I filled it out along with my \$70.00 and hand-
2 delivered it to Ms. Jordan on March 19th. Ms. Jordan stated she would send the
3 application to Herb Hein for approval. This is the sum total of where it stands now. I do
4 not have the irrigation meter yet and my check has not been cashed.


