MOTION FOR STAY OF PROCEEDINGS PENDING JUDICIAL REVIEW

Objector, HERNANDO COUNTY, through counsel and pursuant to Fla. R. App. P. 9.310(a)

Case No.: 090478-WS

and Fla. Admin. Code R. 25-22.061(2), hereby files its Motion for Stay of Proceedings Pending

Judicial Review, and states:

HERNANDO COUNTY has initiated a quo warranto proceeding in the First District Court

of Appeal to review the Amendatory Order, rendered by the Florida Public Service Commission (the

"Commission") on March 12, 2010. This proceeding is styled Hernando County v. The Florida

Public Service Commission, Case Number 1D10-1784.

Pursuant to Fla. Admin. Code R. 25-22.061(2), a party seeking to stay a final or nonfinal

order of the Commission shall file a motion with the Commission. The Commission may, among

other things, consider: (a) whether the movant is likely to prevail on appeal; (b) whether the movant

is likely to suffer irreparable harm if the stay is not granted; and (c) whether the delay will cause

substantial harm or be contrary to the public interest. HERNANDO COUNTY will address each

consideration in turn.

The pending quo warranto petition is based on interpreting Fla. Stat. § 367.171.

HERNANDO COUNTY disputes the Commission's interpretation as set forth in the Commission's

Amendatory Order. In the event that the First District Court of Appeal issues an order to show

cause, the Court will then likely resolve this dispute. Naturally, to predict the likelihood of success

of HERNANDO COUNTY's petition, at this time, depends upon where one sits. Instead, HERNANDO COUNTY will focus on the second and third considerations of the Rule.

Skyland Utilities, LLC. ("Skyland") stated in its pending application that it seeks to operate a water and wastewater utility in Hernando and Pasco Counties. Currently, Skyland has no infrastructure or operations in either County. In fact, should Skyland's application be granted by the Commission, Skyland's is only proposing about twenty (20) new residential connections in Hernando County, for example, during its first year of proposed operations (Application, Exhibit D, at Table D-2). Further, Skyland will be operating on land owned by a related or parent entity. Consequently, any stay of these proceedings should not cause substantial harm to Skyland based upon its representations within the four corners of its application. On the other hand, HERNANDO COUNTY will have to expend public dollars, resources and staff time preparing and filing prehearing testimony and preparing for hearing in a matter which may become moot [to HERNANDO COUNTY] depending upon the future actions of the First District Court of Appeal. Here, the public interest weighs on the side of HERNANDO COUNTY, a local government, not having to commit public dollars, resources and staff time in this proceeding until the First District Court of Appeal acts on the pending quo warranto petition. In sum, it is now up to the First District to determine if HERNANDO COUNTY will be required to participate in this administrative action or be dismissed as a party.

WHEREFORE, HERNANDO COUNTY respectfully requests that the Commission enter an order staying this administrative proceeding in its entirety pending judicial review/action by the First District Court of Appeal, and granting any other such relief that is just and proper.
