**THIRD NOTICE OF INTENT TO REQUEST

Progress Energy Florida ("PEF" or the "Company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, files this Third Notice of Intent to Request Confidential Classification of the confidential portions of the documents produced in response to the Florida Public Service Commission's Staff's ("Staff") First Request for Production of Documents (Nos. 1-3), specifically numbers 1 and 3, and the documents produced in response to Staff's First Set of Interrogatories (Nos. 1-3), specifically number 1A. Portions of these documents contain proprietary confidential business information, the disclosure of which would harm PEF's competitive business interests, including confidential contractual information, the disclosure of which would impair PEF's ability to contract for goods or services on favorable terms. These documents meet the definition of proprietary confidential business information pursuant to section 366.093(3)(d) & (e), Florida Statutes.
