Enclosed for filing on behalf of Embarq Florida, Inc. d/b/a CenturyLink, is the confidential 1st Quarter-2010, Schedule 8 Report, as required by FPSC Rule 25.4.0185.

CenturyLink considers the data provided in this response to be proprietary and is filing it under a claim of confidential treatment pursuant to 364.183(1), Florida Statutes and Rule 25.22.006(5), Florida Administrative Code. In that regard, attached are two redacted copies and one original highlighted copy of the material CenturyLink claims is confidential and proprietary.

CenturyLink considers the highlighted information confidential because it contains the number of residence and business access lines by Retail, Resale and UNE-P. Competitors can use this information to gauge market share. In addition, CenturyLink is required by its Interconnection Agreements (ICA) as well as Section 222 of the Communications Act to protect the confidentiality of proprietary information of and relating to its wholesale customers.

CenturyLink understands this information will be protected from public disclosure until returned to the Company. Pursuant to 364.183(4) staff may retain this information for as long as is necessary for the commission to conduct its business.
