1. Interveners will be participating in the Supplemental Hearing in the above-captioned matter on May 3, 2010.
2. Interveners have consulted with Petitioners' Counsel requesting that Petitioners' stipulate to the documents listed herein. Counsel has declined to stipulate to these documents.

Intervenors include in the hard copy exhibits a copy of the minutes' pages recording the Agenda Item and action taken. *The Minutes of these meetings have been stipulated to by Petitioners as DRD Exh #7.*

5. Each of the foregoing documents shall be provided on separate CD's, fifteen duplicates, with relevant pages provided in hard copy, and fifteen duplicates, at the Hearing.

WHEREFORE, for all the foregoing reasons Interveners request that these documents be granted official recognition.
