PURPOSE AND PROCEDURE

The purpose of this hearing is to consider the protest by East Marion Sanitary Systems, Inc. of the portion of Commission Order No. PSC-09-0263-TRF-WU, requiring East Marion Sanitary Systems, Inc. to connect certain customers' irrigation meters at the prior tariff rate. The Commission will also consider any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any motions from the bench or may take the matter under advisement.

At the hearing, all parties shall be given the opportunity to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on May 13, 2010. All witnesses shall be subject to cross-examination at the conclusion of their testimony.


