

Re: CIMCO Communications, Inc. Request to Surrender its Interexchange Authorization

Dear Ms. Cole:

CIMCO Communications, Inc. (now known as Cap Capital, Inc.) (the "Company"), by undersigned counsel, requests that the Florida Public Service Commission ("Commission") cancel its interexchange authorization granted by, and rescind all tariffs on file with, the Commission, effective March 16, 2010. The Company holds authority (IXC Registration TI559) to provide interexchange services pursuant PAA Order No. PSC-96-1528-FOF-TI issued by the Commission on December 16, 1996 (the "Authorization").

On March 16, 2010, the Company completed a transaction with Comcast Phone, LLC whereby the Company transferred all of its assets and customers to Comcast Phone, LLC and certain of its affiliates.¹ As a result of the transaction, the Company no longer provides telecommunications services in Florida. The Company, therefore, no longer requires its Authorization. Because the Company does not serve any customers or have any active telecommunications operations in Florida, the Company respectfully submits that the surrender of its Authorization and withdrawal of its tariffs is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.
