Elisabeth –

To the extent it makes a difference in how the order approving the Peoples Gas System tariff changes approved at yesterday's agenda conference in the above docket, FERC issued an order late last week extending the date for compliance/implementation by major non-interstate pipelines (i.e., Peoples) from July 1, 2010 to September 1, 2010. I attach a copy of FERC's extension of time order for your information. In the Staff Recommendation that was approved by the Commission yesterday, the last sentence of the first paragraph of the Staff Analysis under Issue 1 states: "Peoples must comply no later than July 1, 2010." You would probably want to change the July 1 date to the extended September 1 date in the order, or at least note that the initial July 1 date was extended to September 1. To me, this does not affect the substance of the recommendation, but if you or Erik Saylor should feel otherwise, feel free to give me a call. If you have other questions, it would probably be best to call Wraye Grimard at Peoples (813-228-4697).

NOTICE OF EXTENSION OF TIME

(May 28, 2010)

Atmos Pipeline-Texas (a division of Atmos Energy Corporation), American Gas Association, Railroad Commission of Texas, and Texas Pipeline Association requested the Commission to extend the July 1, 2010 deadline for major non-interstate pipelines to comply with the requirements of Order Nos. 720 and 720-A.<sup>1</sup> The above organizations believe that the requests for rehearing and clarification of Order No. 720-A now before the Commission may affect the posting obligations of major non-interstate pipelines and accordingly, believe that additional time will allow major non-interstate pipelines to comply with the new requirements based on any additional guidance that the Commission will provide in the future.

Upon consideration, notice is hereby given that major non-interstate pipelines are granted an extension of time until September 1, 2010 to comply with Order Nos. 720 and 720-A.

The requesting parties incorrectly stated that the compliance deadline is June 21, 2010, 150 days from the issuance of Order No. 720-A. As corrected in the Errata Notice on Compliance Deadline issued on January 27, 2010 in Docket No. RM08-2-001, major non-interstate pipelines must comply with the order no later than 150 days following the publication of Order No. 720-A in the *Federal Register*.
