Dear Mr. Burnett and Mr. Brown:

By this letter, the Commission staff requests that Progress Energy Florida, Inc. (PEF) and the Withlacoochee River Electric Cooperative, Inc. (WREC) provide responses to the following data requests.

Staff Data Request No. 1

1. The joint petition refers to a Citrus County requirement that PEF vacate the right-of-way that currently crosses a runway within the Crystal River Airport. Please provide documentation from Citrus County which supports this requirement.
2. The joint petition references a plan to transfer PEF's distribution facilities used exclusively for providing service to the affected customers. Please provide more detailed information about the specifics of the transfer, including information about the terms to which both PEF and WREC will adhere and the value of any and all facilities and assets involved.
3. The sample of the letter sent to customers as notification of the territorial agreement mentions how customer deposits will be handled by both PEF and WREC. Please provide more detailed information regarding the deposit that may be required by WREC for each

4. The parties request that the Commission expeditiously grant this petition to facilitate the County's request to vacate. Please advise if there is a certain date set that is associated with Citrus County's request.
5. Please advise of the anticipated date that the customer transfer will occur.
