PRECAUTIONARY BOIL WATER NOTICE

TO: ALL RESIDENTS OF THE NALCREST, LAKESHORE AREA COMMUNITIES INCLUDING GRANADA CONDOS, WALDEN SHORES MHP, AND VILLAGE GREEN APTS.

A Low Chlorine residual was EXPERIENCED ON **June 21**. The cause of this problem was a malfunction in the Chlorination system at the water plant. We are working expeditiously to correct this problem.

AS A PRECAUTION, WE ADVISE THAT ALL WATER USED FOR DRINKING OR COOKING BE BOILED. A ROLLING BOIL OF ONE MINUTE IS SUFFICIENT. AS AN ALTERNATIVE BOTTLED WATER MAY BE USED.

THIS "PRECAUTIONARY BOIL WATER NOTICE" WILL REMAIN IN EFFECT UNTIL A BACTERIOLOGICAL SURVEY SHOWS THAT THE WATER IS SAFE TO DRINK.

RESIDENTS WILL BE NOTIFIED WHEN TESTING IS COMPLETE AND BOIL WATER NOTICE IS RESCINDED.
