VERIZON FLORIDA LLC'S RESPONSE TO MOTION FOR LEAVE TO FILE AMENDED POST-HEARING REPLY BRIEF

Verizon Florida LLC ("Verizon") does not oppose the Motion for Leave to File Amended Post-Hearing Reply Brief filed by Bright House Networks Information Services (Florida), LLC ("Bright House").

The parties filed their reply briefs on July 30, 2010. On August 3, Verizon filed a motion to strike the portions of Bright House's brief that exceeded the 20-page limit specified in the Prehearing Order. On the same day, Bright House (which had been notified of the problem on August 2 by Verizon) filed its motion for leave to file an amended reply brief. Bright House stated that the error was not intentional, apologized and contemporaneously filed an amended reply brief that complied with the 20-page limit. Given this response, Verizon does not oppose Bright House's motion, so long as its initial reply brief is stricken and not used for any purpose in this case. Verizon is willing to withdraw its motion to strike on the same condition.
