First Amendment to Wireless Traffic Exchange Agreement

The Wireless Traffic Exchange Agreement, effective the 1st day of January 2006, between the TDS Telecommunications Corporation affiliates or subsidiaries identified on Appendix A of the named Agreement ("TDS TELECOM"), and the Verizon Wireless entities listed on the signature page of named agreement, ("VZW"), approved by the Florida Public Service Commission in Docket 060676-TP on January 11, 2007 is hereby amended as follows:

To Appendix B - Point(s) of Interconnection

- 1. The Point of Connection for traffic to and from the Quincy, Gretna and Greensboro exchanges of TDS TELECOM's Quincy Telephone Company shall be at the Quincy central office (QNCYFLXADS0).

The remaining terms and conditions of the Agreement shall remain in effect. This Amendment shall be effective as of June 1, 2010.
