Comtel Telecom Assets LP (“Comtel”) and Matrix Telecom, Inc. (“Matrix”) (together, the “Petitioners”), by their undersigned counsel, and in accordance with Commission Order No. PSC-10-03850CO-TP granted on June 15, 2010, hereby inform the Commission that substantially all of the assets and customers of Comtel were transferred to Matrix on August 2, 2010, as contemplated in the Petition filed in the above docket. Comtel will separately request cancellation of its Certificate of Public Convenience pursuant to Commission regulations.¹

¹ In Florida, Comtel is authorized to provide (1) competitive local exchange telecommunications services pursuant to CLEC Certificate Nos. 5687 (using d/b/a VarTec Telecom and Clear Choice Communications), 4695 (using d/b/a Excel Telecommunications) and 4699 (using d/b/a VarTec Solutions), which were transferred to Comtel pursuant to Order Nos. PSC-05-1241-PAA-TX (Dec. 19, 2005) and PSC-06-0040-CO-TI (Jan. 13, 2006) issued in Docket No. 050648-TA and (2) long distance telecommunications services pursuant to IXC Registration Nos. TK025 (using d/b/a VarTec Telecom and Clear Choice Communications), TK028 (using d/b/a Excel Telecommunications) and TK029 (using d/b/a VarTec Solutions).
