On August 30, 2010, the petitioner, by letter, informed the Commission that it was withdrawing its request for an increase in miscellaneous service charges. On September 10, 2010, the petitioner, by email, confirmed that it was voluntarily withdrawing its request, and requested that the docket be closed. Pursuant to Section 2.07(C)(2)(d) of the Administrative Procedures Manual, the Office of Commission Clerk may administratively close dockets upon the joint recommendation of the OPR division and the Office of General Counsel for dockets initiated by the petitioner in which the petitioner "... seeks to withdraw its initial pleading and staff has determined that there are no pending issues that need to be addressed by the Commission regarding the filing, no request for refund of filing fee has been made, and no agency action has been taken."

In this case, staff has determined there is no pending issues to address, there is no filing fee to be refunded nor did the petitioner request a refund, and no agency action has been taken. Therefore, there appears to be no other outstanding matters which require action by the Commission, and staff recommends that this docket should be administratively closed.)
