## PROGRESS ENERGY FLORIDA, INC.'S MOTION TO ESTABLISH SEPARATE "SPIN-OFF" DOCKET TO EXAMINE THE OUTAGE AND REPLACEMENT FUEL/POWER COSTS ASSOCIATED WITH THE CR3 STEAM GENERATOR REPLACEMENT PROJECT

Progress Energy Florida, Inc. ("PEF" or the "Company"), moves to establish a separate "spin-off" docket to enable the Commission and all interested parties to review facts and information related to the Crystal River Unit 3 ("CR3") steam generator replacement project and the subsequent delamination that was discovered during CR3's Refueling Outage 16.
