# JOINT MOTION FOR CHANGE OF HEARING DATES

COME NOW Choctawhatchee Electric Cooperative, Inc. ("CHELCO") and Gulf Power Company ("Gulf Power") and jointly request a change of hearing dates in this docket and state:
