Larry,

I've asked for an update on the settlement talks between ADT and AT&T. I assume that a deal is imminent but I can't promise anything. I've emphasized the importance of getting something together before Thursday if at all possible.

To my knowledge the deal points have not changed and the main hold up is identifying the LifeConnex customers. One of the deal points, you will recall, is that service to the remaining LifeConnex customers would be terminated on a schedule to be determined by the staff.

The attached draft notice assumes where we expect to end up, but, as I said, I do not have an update. I'm just trying to get ahead of the curve. The draft notice assumes about a 10 day turnaround, but those are soft dates and staff will tell us when to send the notice and what the term date will be.

When I know more, I'll let you know.

Sorry if you had to work on a recommendation on weekends and/or holiday days.
