WITHDRAWAL OF REQUEST  
FOR EXTENDED CONFIDENTIAL CLASSIFICATION

GULF POWER COMPANY [“Gulf Power”, “Gulf”, or the “Company”], by and through its undersigned attorney, hereby withdraws its request that the Florida Public Service Commission enter an order granting extended confidential classification for certain information contained in a purchased power agreement between Shell Energy North America (US), L.P. (“Shell”) and Gulf Power. As grounds for this withdrawal, the Company states:

1. On April 6, 2009, Gulf Power filed its initial request for confidential classification of certain information contained in a purchased power agreement between Shell and Gulf Power. See, Document No. 03001-09
2. On May 1, 2009, the Commission entered an order granting Gulf Power’s request. See, PSC-09-0294-CFO-EI (the “Order”).
3. On October 27, 2010, Gulf submitted its request that the Commission enter an order extending the confidential classification of the information described in Exhibit “A” (Document No. 03002-09) to the Commission’s Order for an additional 18-month period. See, Document No. 08957-10
4. On November 3, 2010, Commission Staff returned Document 03002-09 to Gulf Power.




