Thank you, your fellow commissioners, and the Public Service Commission (PSC) Staff for the collective effort to evaluate the merits of Dockets 100345, 100346 and 100347. Those dockets, which were filed by Progress Energy Florida (PEF) in support of three 16-20MW woody biomass fueled power only projects under development by Hathaway Renewable Energy, Inc., are being recommended for disapproval by the PSC Staff for the following reasons:

- 1. Need for Power
- 2. Cost-Effectiveness
- 3. Early Termination Security
- 4. Performance Guarantees

It is our understanding that should the capacity payments contained within the subject dockets be recalculated and revised using 2010 baseline data, vice the 2009 baseline data used, that items 2-4 above could be remedied to meet Commission policy. With respect to item 1 above, it would seem that based upon the PSC Staff's written comments, the Commission has the latitude to approve the dockets in question without establishing the need for power.

Hathaway Renewable Energy, Inc., requests that the Commission exercise it's considerable discretion in the matter of approving Dockets 100345, 100346 and 100347 by providing additional time for PEF and Hathaway to recalculate capacity rates using 2010 baseline data and to revise Dockets 100345, 100346 and 100347 accordingly. We further request that the Commission direct PSC Staff members to working closely with PEF and Hathaway to "get the numbers right," and to resubmit Dockets 100345, 100346 and 100347 for final consideration at the next available hearing.

By honoring the our request for additional time and PSC Staff support to recalculate and revise the capacity rates contained within Dockets 100345, 100346 and 100347, the Commission could potentially advance the collective interest of Florida taxpayers by facilitating projects that would:

- 1. Create 75 full-time power plant jobs, annual payroll estimated at \$5,000,000.00
- 2. Create 30 full-time forestry jobs, annual payroll estimated at \$2,000,000.00
