PETITION FOR APPROVAL OF GPIF RESULTS FOR THE PERIOD JANUARY 2011 THROUGH DECEMBER 2011

Florida Power & Light Company ("FPL") hereby Petitions this Commission for approval of a Generating Performance Incentive Factor ("GPIF") reward of \$7,703,912 for the period January 2011 through December 2011. In support of this Petition, FPL states as follows:

By Order No.PSC-11-0094-FOF-EI dated February 1, 2011, the Commission approved GPIF Targets for FPL for the period January 2011 through December 2011. The application of the GPIF formula to FPL's performance during that period produces a reward of \$7,703,912. The calculation of FPL's GPIF reward is discussed and supported in the prepared testimony and exhibits of FPL witness J. Carine Bullock, which are being filed with and incorporated in this Petition.

WHEREFORE, Florida Power & Light Company respectfully requests the Commission to approve \$7,703,912 as FPL's GPIF reward for the period January 2011 through December 2011 and include this amount in the calculation of the Fuel Cost Recovery Factor for the period beginning January 2013.
