BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

City of Ocala, OUS - Telecommunications (OUS) requested the cancellation of its Certificate of Authority No. 4428. OUS has complied with the provisions of Rule 25-24.820(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2011.
