Nonnye would like to know whether a utility can have two class types. In the case of Farnton, its water system (WU859) is currently a Class C utility. However, the recent order regarding its wastewater system (SU952) specifies that it will be a Class B utility *at build-out*. As far as you are aware, can each company code have a different class, or should we make both codes Class C since the wastewater system would *currently* be considered Class C (annual revenues of less than \$200,000)?
