**NOTICE OF VOLUNTARY DISMISSAL**

Bright House Networks Information Services (Florida), LLC, ("Bright House") hereby files this Notice of Voluntary Dismissal, with prejudice, of its Complaint in this Docket. By this Notice, Bright House dismisses, with prejudice, its Complaint dated February 22, 2011, against MCI Communications Services Inc. d/b/a Verizon Business Services ("Verizon"), (together jointly referred to herein as "Parties"). The Parties have reached a mutually agreeable resolution of the dispute at the heart of this case such that this proceeding can be terminated. In support of this Notice, Bright House states the following:

1. Bright House's Complaint initiating this proceeding was filed on February 22, 2011. The initial Order Establishing Procedure in this docket, Order No. PSC-11-0417-PCO-TP, was issued September 27, 2011.
2. On October 27, 2011, the FCC adopted its Report and Order and Notice of Proposed Rulemaking ("Order") addressing comprehensive reforms to the Universal Service Fund and Intercarrier Compensation mechanisms.<sup>1</sup> The complete text of the Order was subsequently issued on November 18, 2011.
3. Based on their analysis and review of the provisions of the FCC's Order addressing intercarrier compensation, the Parties engaged in initial discussions



geared towards the development of a possible settlement of the matters in dispute in this case. Those discussions proved fruitful and resulted in the Parties achieving an agreement in principle. Thereafter, recognizing that the Parties' had reached a mutually acceptable resolution and that additional time would allow the Parties to finalize a settlement, the Prehearing Officer granted Bright House's Motion to Suspend the remaining procedural schedule by Order PSC-12-0018-PCO-TP, issued January 6, 2012.

4. The Parties have since finalized a settlement of this matter.

WHEREFORE, Bright House respectfully requests that the Commission acknowledge this Voluntary Dismissal, with prejudice, and close this Docket.


