5 **PLEASE TAKE NOTICE THAT** Carol Wu, Chapter 7 Trustee ("Trustee") of the
6 following bankruptcy estates: StarVox Communications, Inc., a California corporation ("SV CA");

23 If the motion is granted the creditors of Debtors will be required to look to the consolidated
24 bankruptcy estate for payment of debts in accordance with the United States Bankruptcy Code.
