Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Progress Energy Florida requests confidential classification of certain highlighted information provided in its Form 423 filings for March and April, 2012, filed on 5/15/2012 (the March report, FPSC Document No. 03136-12), and 6/1/2012 (the April report, FPSC Document No. 03550-12).

Staff has reviewed PEF's confidentiality requests. In staff's opinion, the requests meet the criteria for confidentiality contained in Section 366.093, Florida Statutes.
