

On August 16, 2011, the Commission issued Order No. PSC-11-0345-PAA-WS, approving an increase in rates and charges for Tymber Creek Utilities, Inc. (Tymber Creek or Utility), including approving both Phase I and Phase II wastewater rates. Phase II rates were approved pending certain pro-forma Utility expenditures related to capital and expense items. Tymber Creek has complied with Commission Order No. PSC-11-0345-PAA-WS regarding the pro-forma expenditures. Therefore, notice is hereby given that the Florida Public Service Commission is approving the implementation of Phase II wastewater rates for Tymber Creek as approved by the above referenced order. The Commission approved Phase II wastewater rates are as follows:

The rates shall be effective for service rendered as of the Commission's stamped approval date on the tariff sheets (anticipated to be July 29, 2012) provided the customers have received notice.

If the effective date of the new rates falls within a regular billing cycle, the initial bills at the new rate may be prorated. The old charges shall be prorated based on the number of days in the billing cycle before the effective date of the new rates. The new charges shall be prorated based on the number of days in the billing cycle on or after the effective date of the new rates.
