Mr. Holt,

I am the Analyst who has been assigned to work with you on your above voluntary cancellation request.

When a company requests voluntary cancellation after January 30th, staff's ability to retroactively cancel a company in good standing December 31, 2011 has expired.

Your company's cancellation request was received by the Commission April 27, 2012 and that request makes the effective date of the cancellation request in 2012.

Companies requesting cancellation after January 30th (2011 RAF payment due date) are also responsible for the minimum 2012 RAF payment of \$600.
